1.  - a). Whether such claims shall arise out of personal injury or property damage,
 - b). Whether caused or contributed by act or omission of the organisers and
 - c). Whether occurring prior to, or during, or after the Wangaratta Historic Motor Show & Fly In event.
2. The entrant also agrees that he/she will indemnify the organisers against any claim as aforesaid which might be made by the driver or passengers in the entrant's vehicle, against the organisers.
